11. Good sportsmanship and courtesy used at all times

13. All Largemouth Bass must be 14" and Spotted Bass 12" in length
14. No dead fish weighed in. No exceptions!
15. All Bass weighed in must be released back into the

 16. All bass must be in bag with water. One bass per bag per hour.
 17. Any preserved or questionable entry will be subject to inspection by marine expert
 18. No contestants may have more than 3 bass in possession during tournament
 19. Contestants that weighed during said hour must remain at site until winners are declared official
 20. All contestants, by entering tournament, agree to allow their boats to be boarded and inspected by officials during said tournament.
 21. All contestants must be at tournament site before hour. After hour must weigh in next time period.
 22. All boats must provide a cell phone number in order to be contacted with hourly winning weights
